## **(A) NFPA 70E And Electrical Safety In The Workplace (2)**

This electrical safety course will cover the latest NFPA 70E code revisions. Its interactive and hands-on approach is designed to help safety directors and key site managers responsible for the safety of their staff. The course will cover some of the key electrical code issues surrounding NFPA 70E, break into several breakout sessions, and provide some clarity to some areas of NFPA 70E that can easily be interpreted differently. We will look at some real-life scenarios that can be challenges for qualified staff to make good decisions with and discuss realistic ways to overcome these challenges. Whether your role is in the safety field, if you're in management, or you are a qualified staff member at your facility, you will benefit from this session.

## **(B) Job Safety Analysis - JSA (2)\***

JSA is a proven process for identifying and controlling operating hazards and costs. Get a step-by-step overview of the process and define your role in making it effective. You'll also learn how to enlist participation from frontline employees, supervisors and upper management. The result: efficient procedures that help reduce personal injuries and operating costs. This program teaches employees the fundamentals of job safety analysis and shares with managers the motivational aspects of managing a JSA program. Both managers and employees benefit from job analysis training. The JSA process will make a safer workplace which means improved production and higher profits for your organization.

## **(C) Incident Investigation (2)\***

This seminar will help you determine the factors that cause preventable incidents and recommend effective, corrective actions. To have an effective safety program you must identify and control hazards, and investigate accidents to determine the causes in order to prevent recurrence.

## **(D) Lift Truck Operator, Train-the-Trainer (1)**

It is an OSHA requirement to train anyone who operates a powered industrial truck, including lift trucks, whether they operate the truck daily or once a year. Participants will learn OSHA requirements; skills required for safe operation, including pre-start safety inspection, general operating and materials handling; establish efficient, preventative maintenances; and more.

## **(E) Industrial Hygiene For The EHS Professional (1)**

Industrial hygiene is the science of anticipating, recognizing, evaluating, and controlling workplace conditions that may cause workers' injury or illness. More and more chemicals are being used within the workplace. Are your workers safe? This course is geared towards the EHS Professional and will help you understand occupational exposure limits for airborne chemicals and noise, identifying what to sample, the proper methods for air and noise sampling, heat stress measurements, office indoor air quality, understanding sampling results, and most importantly, what to do with those results.

## **(F) Overhead Crane, Train-the-Trainer (2)**

This train-the-trainer course will cover how to safely operate an overhead crane including:

  - (g.) Proper crane operation (do's and don'ts of overhead cranes);
  - (h.) Crane safety components - what they do and why they are important.

#### #1 OSHA Top 10 Most Frequently Cited Standards (2)

Every fall, OSHA publishes their top 10 most frequently cited standards. Why should organizations care? Because it highlights the most common workplace safety violations, allowing employers to proactively identify and address potential hazards in their workplaces, preventing injuries, illnesses, and potential legal issues by taking preventative measures based on the most prevalent risks that OSHA inspectors are likely to look for during site visits. Essentially, it's a guide to prioritize safety improvements where they are most needed to protect workers and avoid citations.

#### #2 Essentials Of Contractor Safety Management (2)

#### #5 Arc Flash Hazard: OSHA Guidance Document & Latest NFPA 70E Emphasis On Electrical Maintenance Impacts PPE Selection - Take Note! (2)

OSHA's arc flash hazard guidance document clarifies rules and answers questions regarding PPE for low voltage work. Is FR/AR PPE needed for 120V work or for de-energizing or simply operating a circuit breaker? OSHA points to NFPA 70E-NFPA 70E emphasis on maintenance condition impacts arc flash likelihood and PPE best practices mitigate the consequences of human error. Improve risk assessment accuracy with proper maintenance practices that reduce incident likelihood and mitigate injury severity with "best practice" PPE selection should an arc flash occur.

#### #6 Safety Concerns Regarding Li-Ion Batteries In General Industry & Construction (1)

Lithium-ion (Li-ion) batteries have become essential for powering tools, equipment, and vehicles across general industry and construction sites—but alongside their advantages come distinct safety risks that must be recognized and managed. This presentation provides a comprehensive overview of how Li-ion batteries work, where they are used, and the primary hazards they present, such as thermal runaway, physical damage, electrical faults, chemical exposures, and the dangers of improper storage and counterfeit products. By drawing on recent real-world incidents and case studies, the session highlights both the potential for catastrophic outcomes and the practical lessons learned in the field.

Drone technology is redefining industrial inspections by eliminating exposure to fall hazards and confined spaces while delivering faster, higher-quality data. Equipped with onboard camera, LiDAR, and ultrasonic thickness sensors, drones can safely assess smoke stacks, tanks, ductwork, roofs, and vessels that are otherwise difficult or dangerous to inspect. This session explores real-world applications, data collection methods, and case studies showing how drone inspections improve safety, reduce downtime, and support informed decision-making.

### #10 I Have A Spill. Now What? (2)

The presentation will also include examples of actual chemical release responses, lessons learned, and provide information to help employers prepare for actual chemical release events.

### **#19 Understanding Fall Protection (2)**

The fall protection demonstration will address standards related to working at heights in the various industries. The program will focus on the PFAS, personal fall arrest systems, harness, connector, anchor and rescue and touch on FPFT, Dropped objects also known as Fall Protection for Tools. 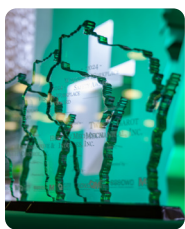
