#1 Paws And Power: Transforming Workplaces With Digital Innovation (2)

Tedi Knox, Safety and Health Coordinator, Milwaukee Tool Ryan Heiar, Sr. Manufacturing Manager, Milwaukee Tool Michael Carter, VP of Manufacturing, Stella and Chewy's

In this joint presentation between two large Wisconsin companies, we will explore the communication and safety challenges these organizations faced and how they strategically addressed them. The companies will share real-life use cases demonstrating how adopting the Weavix platform transformed team collaboration and efficiency, resulting in significant improvements. You will gain insights into practical outcomes and lessons learned that can inform your own approaches to overcoming similar challenges in your operations.

#2 Emergency Response Partnership With AT&T & FirstNet: Utilizing Public Safety Mission Critical Communications (2) Brandon Harris, FirstNet Senior Application Executive, AT&T Public Sector Aaron Midthun, FirstNet Senior Application Executive, AT&T Public Sector

During our discussion, we will cover topics related to our partnership in the field on a daily basis, prior to an unplanned event or when an Emergency Operations Center has been activated. Topics include: deploying with FirstNet, mission critical solutions, understanding the FirstNet deployable program, and network enhancements unique to FirstNet and AT&T. Using the network status tool and uplift tool, FirstNet devices and applications, using a FirstNet device cache, incorporating FirstNet into your communications plans along with updates specific to Wisconsin will be covered.

## #3 Safely Integrating Alternate Populations From A Shrinking Employment Pool (2)

#### Ellen Gallo, CSP, CPE, Senior Risk Consultant, Aon Global Risk Consulting

As an increasing segment of the population retires, we need to take a closer look at keeping everyone employed; even those who are neurodivergent, PTSD impacted, or looking for second chance employment. In the neurodivergent sphere, recognizing conditions in the Autism Spectrum allows us to create a safe environment and welcome those individuals, many of whom have significant creativity and memory skills. Veterans and first responders can also help fill the employment void by providing the neurodivergent-friendly workplace that strives to eliminate the triggers, allowing those suffering PTSD symptoms to work. Second chance employment is another untapped employment source considering one out of every three adults has a criminal record. Those previously incarcerated may have skills in CNC machining and the trades; two areas in very short supply. Embracing diversity means expanding the population to match a higher percentage of the population. By modifying the workplace and considering alternate populations, employers can reduce their job shortages and potentially reduce turnover by employing these very loyal individuals. An added bonus is the presence of grants and non-profit organizations who provide free guidance to employ these groups.

## #4 Look Again! Vehicle/Pedestrian Safety (1) Jim Sutton, Director – Safety and Occupational Health, Mercury Marine

Presenter will share their experience from a forklift/pedestrian event from December 2023, including incident investigation, corrective actions, subsequent follow-up with OSHA, lesson learned, ah-ha moments, insights gained and a variety of enhancements undertaken to reduce the likelihood of future events.

Over 50% of U.S. employees exhibit quiet quitting, disengaging at work without formally resigning. Employee burnout, caused by heavy workloads and staff shortages, further complicates safety efforts. Effective safety leaders play a crucial role in motivating and listening to employees, fostering a safety-focused culture. Convincing senior management to prioritize safety is essential for overall safety performance. This presentation aims to address quiet quitting, emphasizing leadership and management engagement to enhance safety culture and employee well-being.

#### #8 New Hire Training That Doesn't Suck (Time, Energy & Money) (1)

## #9 Company Culture Is The Foundation Of Your Safety Program (2)

#### Ami Gignac, Director of Operations, GLC Minerals Katie Woodhall, Director of Safety, The Beaver Companies

Safety programs are evolving, moving beyond regulatory training, tracking and analyzing lagging safety statistics, and posting catchy outdated safety slogans in our operations. We have to pivot to a proactive holistic approach, rather than a reactive, policy-driven operation. We are shifting to behavior-based safety programs that are rooted in the overall culture. But what if your company culture isn't clearly defined and your plan to shift to a trusting behavioral safety program isn't showing results? This session will explore the definition and types of company cultures, how this directly impacts your safety program, and what organizations can do to shift culture right now.

## #10 Safety & Security Concerns When Terminating A Potentially Violent Employee (2)

#### Ted Hayes, Senior Risk Manager, M3 Insurance

The termination of an employee can be a stressful situation for the affected employee, your human resources department, and others in your organization. A threat of violence, perceived or real, can turn the termination process into a dangerous situation quickly. By

ensuring your organization has developed a plan to address the threats of violence, the chances of a termination resulting in injury (or even death) can be minimized or eliminated. This presentation will address recommended security controls to keep your staff safe before, during and after terminating an employee who displays threatening behavior. The presentation will also address specific room security controls that need to be in place to ensure an effective lockdown and evacuation can take place.

## #11 Applying Work-Related Exceptions For The OSHA 300 Log (2) Edwin Zalewski, Senior Editor, J. J. Keller & Associates, Inc.

You probably feel like every incident is work-related on the 300 Log. OSHA cast a broad net, but provided eight narrow exceptions. Knowing when they apply is key to correctly recording incidents. This review of OSHA's responses to real-world cases will illustrate how to correctly apply the exceptions, particularly for employees who travel or work at home.

## #12 Understanding Fall Protection (2) Patrick Harel, Senior Fall Protection Specialist, 3M

The fall protection demonstration will address standards related to working at heights in various industries. The program will focus on the PFAS, personal fall arrest systems, harness, connector, anchor and rescue and touch on FPFT, dropped objects also known as Fall Protection for Tools. Each category will emphasis the proper selection, use and inspection of the system. During the connector session a load cell test weight is dropped to simulate the impact forces on the body in a free fall. With and without a shock absorbing lanyard. This drop will emphasize the required fall clearance distance requirement versus the use of a selfretracting lifeline to reduce clearance requirements. The load cell will give a visual force impact load that would be applied to the person and also the load on the anchor points. Suspension trauma will be addressed and the important need for a proper onsite rescue plan. We will also discuss and explain the NEW ANSI-ASSP Z359.14-2021 Regulation and how it affects you.

## #13 Risk Assessment Methodologies (2) Gabe Koenig, Machine Safety Engineer III, Pieper Automation

This seminar helps lay the groundwork for developing strong risk assessment skills. In this session, you will learn about the different types of risk assessment, which type of

This presentation will review the OSHA requirements of lockout/tagout and the hazards when not used. It will review when lockout/tagout is required and what an adequate hazardous energy control program includes. A review of what a machine specific procedure should entail and the obligations of the employer to ensure procedures are being utilized. Statistics and local OSHA inspection examples will be used.

#### #15 OSHA Top 10 Most Frequently Cited Standards (2) JoAnn Dankert, Principal Consultant, Training Concepts and Solutions

Every fall, OSHA publishes their top 10 most frequently cited standards. Why should organizations care? Because it highlights the most common workplace safety violations, allowing employers to proactively identify and address potential hazards in their workplaces, preventing injuries, illnesses, and potential legal issues by taking preventative measures based on the most prevalent risks that OSHA inspectors are likely to look for during site visits. Essentially, it's a guide to prioritize safety improvements where they are most needed to protect workers and avoid citations.

#### #16 Slips Of The Tongue – Part II: Communicating In A Crisis (1) Nick Novak, President, Midwest Food Products Association & Former Safety Council Communications Advisor

Communicating in any situation can have its difficulties. Whether you are unveiling a new safety policy to employees or have to have a tough conversation with a coworker, several challenges could exist. How do you get across your main points? What is the best way to handle the conversation? But what if you have to think about all of these things following a serious injury at your company or something even worse? In a crisis, a well-thought-out communications plan is critical. This session will break down how to determine if a situation truly is a crisis, and if it is, what steps to take in response. The speaker's decade-plus of experience will help you be prepared for the crisis we all hope never actually happens.

#### #17 Culture Of Commitment (3)

The presentation will describe and answer the question "What is culture of commitment"? This is the story of how RGL is moving into a culture of commitment and the positive impacts that we have seen as a result. A way of doing business, prioritizes long-term goals and values over short-term gains, empowers teammates to take ownership of their work and areas, holds teammates accountable for their actions, supports teammates in pursuit of excellence, moves RGL from reactive to proactive approach, predict and then prevent. The presentation will give examples of how a culture of commitment positively impacts the company, teammates, and customers in many ways including risk management and safety, productivity, teammate engagement, turnover and many other ways.

#### #18 Active Threat Preparedness And De-Escalation Strategies (2) Drew Moldenhauer. Owner and Master Instructor. Blue Ethos **Specialized Training**

#### Richard Webb, Owner and Master Instructor, Blue Ethos Specialized Training

This session is designed to equip public and private sector organizations with comprehensive training on active threat preparedness and response. The focus will be on enhancing safety and security protocols, preparing for both external and internal threats, and developing rapid response techniques through situational awareness. Participants will learn fundamental and easily recallable skills to increase their chances of survival during an encounter. Additionally, the session will cover effective de-escalation strategies to manage potential conflicts before they escalate into dangerous situations. By analyzing case studies, participants will gain insights into successful and unsuccessful responses from past incidents, providing valuable lessons to inform future actions. These tools will empower employees to feel secure and confident in their workplace, fostering a safer environment for all.

#### #19 Retraining: Why It Doesn't Work (2)

#### George Gruetzmacher, Industrial Hygiene Engineer/Scientist, WI State **Laboratory of Hygiene**

You've had an incident, and the investigator recommends training. Just like last time. You repeat the classroom session, or the online training program once again. Does it really make a difference and help? Repeating instructional training doesn't really help in most cases. Many things can affect behavior. This session will look at the results pyramid, in combination with other models to help identify and justify what "training" has the most potential to be effective.

#### #20 Hoofs And Feathers - OSHA's Food Manufacturing **Emphasis Program (2)**

#### OSHA Staff Invited, U.S. Department of Labor-OSHA

This presentation will review OSHA's Regional Emphasis Program for food manufacturing industry. The session will go through the industries that are targeted, hazards that are commonly found, and common abatement methods to reduce these risks.

#### #21 Are Incident Rates Reliable And Representative Measures Of **Safety Program Performance? (2)**

#### **Todd Loushine, Associate Professor, University of Wisconsin-Whitewater**

Does your company use TRIR or DART as a measure of program performance or your job performance? Do you ever find yourself anxious or stressed having to convince others that the safety program is doing better than what the metrics show? Employees with mental health issues are twice as likely to be distracted on the job. More mistakes increase the likelihood of accidents, resulting in more injuries and legal implications for your company. Additionally, the likelihood of accidents is even greater when exhaustion and mental absenteeism are in the equation. The two OSHA recommended trainings for workplace stress, Mental Health First Aid & QPR-Question, Persuade, Refer - Suicide Awareness will be discussed as well as highlighting the National Safety Council mental health cost calculator. Additionally, Wisconsin statistics from the 988 program will be shared as well as other state and national resources.

Assessing worker exposures to metals in foundries, weld shops, and machine shops is commonly done, but the resulting data can often be difficult to interpret or can miss significant exposures entirely. Relying on SDSs and alloy specifications when determining a sampling scope is a good practice, but in certain applications this approach can miss critical metals. Cadmium in a torch-cutting operation? Beryllium in a blast booth? Hexavalent chromium from mild steel operations? These exposures are indeed possible, and even employers with mountains of industrial hygiene data can suddenly be faced with an unwelcome surprise.
